Municipal Class Environmental Assessment

Cainsville Water, Wastewater, and Stormwater Servicing Master Servicing Plan

The County of Brant has completed a Water, Wastewater, and Stormwater Master Servicing Plan for Cainsville through the Municipal Class Environmental Assessment process.

The Master Service Plan considered and evaluated servicing alternatives and identified the preferred approach for water supply, water storage, water distribution, wastewater treatment, wastewater conveyance, and stormwater management. The preferred servicing approaches for these components are outlined in the table below along with any future studies that must be completed to fulfil Municipal Class Environmental Assessment requirements.

Category	Preferred Alternative(s):
Water Supply, Storage and Distribution	 Increase Water Acquisition from the City of Brantford Build a New Standpipe and Booster Pumping Station to Work with the Existing Elevated Tank Create Internal Distribution Redundancy by Connecting New Watermains to Existing Cainsville Water Distribution System, Increase Existing Watermain Sizes as Needed
Wastewater Collection, Conveyance and Treatment	 Extend new sanitary sewers to unserviced areas. Construct Local Sanitary Pumping Stations or low-pressure sewers where conventional sewers cannot service an area. Construct 2 Main Sewage Pumping Stations to pump Wastewater to the City of Brantford for treatment. Maintain Existing Lagoons until all wastewater is pumped to the City of Brantford for treatment. Reconfigure a portion of the lagoons for flow equalization.
Stormwater Management	The preferred stormwater management projects are a combination of solutions including new stormwater management facilities, onsite quantity and quality controls, new sewers, ditching, , curbs, erosion protection, stormwater infiltration, outlet improvements
